### Calculating KRI Licensing Fee:

**There are no deductions** but if the registration price includes student payments for: Room & Board (at live in courses), White Tantric, the required 20 KY classes or the Aquarian Trainer Manual and if these charges are included in the registration price, then they may be deducted from the price before calculating the royalty.

For Example: Early Registration Price is \$3,000. This includes White Tantric which costs \$180. It includes the Aquarian Trainer Manual which costs \$120. The adjusted Early Registration price would be calculated in this manner: \$3,000- \$180 - \$120= \$2,700.

Please note: There are no deductions for travel costs, administrative costs, classroom rent, equipment rental, or trainer fees.
